

# **CONTEST RULES**

## **InCanada Panel Contest (“InCanada Panel”)**

**Contest Period: April 1, 2018 - March 31, 2019 (“Contest Period”)**

### **1. HOW TO ENTER**

**No purchase required.**

Thank you for joining the InCanada Panel. As a registered member of the InCanada Panel, you will now be automatically entered into Contests throughout the Contest Period. If you do not want to be entered into any of the Contests please email us at [support@incanadapanel.ca](mailto:support@incanadapanel.ca). Upon joining the InCanada Panel for the first time, you will be automatically entered into a draw to win \$500. By participating in a survey within a given month, you will be automatically entered into four (4) draws with a chance to win \$100 in each.

### **NO PURCHASE NECESSARY TO ENTER OR WIN**

All entries become the exclusive property of InCanada Panel (“Contest Administrator”) and will not be acknowledged or returned.

### **2. ELIGIBILITY**

The Contests are open to all Canadian residents who are eighteen (18) years of age or older who have registered for the InCanada Panel (“Contestants”).

### **3. PROCEDURE FOR AWARDING PRIZES**

Random draws will be conducted in Vancouver, British Columbia periodically during the Contest Period from amongst all Contestants.

Winner(s) will be notified by email by the Contest Administrator or a third party acting on behalf of the Contest Administrator (“Vision Critical”) within fifteen (15) days of the drawings. Prize will be awarded only upon verification by the Contest Administrator or Vision Critical that all Contest requirements have been met by the winner(s). No correspondence will be entered into except with selected Contestants at the email address listed on the Contest Administrator’s or Vision Critical’s systems. The winner(s) will have five (5) calendar days from notification to accept the Prize by email, and will be instructed whom to contact at that time.

By completing and returning the Survey Notification Form, the Contestant is required to: (i) consent to Contest Administrator providing the Contestant’s name, email address and province/state details to Vision Critical which will then contact the Contestant to fulfill the Prize; (ii) acknowledge that to fulfill the Prize, the Contestant may be required to set up a password-protected account with Pay Incentives and provide the following information: date of birth, gender, mailing address and certain banking information, if Contestant elects to redeem the Prize by bank deposit (where such option is available) and agree to Vision Critical’s Terms & Conditions related to the Prize; and (iii) gives permission to Contest Administrator, at its option, to publish or otherwise use the Contestant’s name, address, photograph, voice and comments, without compensation, in any publicity carried out by Contest Administrator or its advertising agencies.

Contest Administrator is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify the winner(s). If a selected Contestant cannot be contacted within the

allotted time Contest Administrator reserves the right to void that entry and select another eligible Contestant for that Prize.

In order to be declared an official winner, the selected Contestant must correctly answer a time-limited skill-testing mathematical question without mechanical or other assistance. The selected Contestant will be required to complete, sign and return to the Contest Administrator a Declaration and Release Form within seven (7) days of receipt of the same. If a selected Contestant fails to complete, sign and return the Declaration and Release Form to the Contest Administrator within seven (7) days of receipt of the same and/or provides an incorrect answer to the skill-testing mathematical question, Contest Administrator reserves the right to void that entry and select another eligible Contestant for that Prize. By completing, signing and returning the Declaration and Release Form, the Contestant (i) confirms compliance with these Contest Rules and Regulations; and (ii) releases and forever discharges Contest Administrator and Vision Critical (“Contest Parties”), their affiliates and subsidiaries and their advertising and promotional agencies from all claims, demands, damages, actions and causes of action arising or to arise by reason of the acceptance or use of the Prize. Any Prize awarded will be delivered by Contest Administrator or Vision Critical to the official winner(s) within four (4) weeks after receipt of the signed and fully completed Declaration and Release Form, including the correct answer to the skill-testing mathematical question.

#### **4. DESCRIPTION OF PRIZE(S)**

Prize ranges from \$100 to \$500, depending upon the study the Contestant participated in.

#### **5. GENERAL RULES**

5.1. By entering the Contest, Contestants agree to abide by these Contest Rules and Regulations and the decisions of Contest Administrator which are final.

5.2. The Prize shall be accepted as is and may not be exchanged or refunded for an amount of money, sold or transferred. No substitutions will be allowed.

5.3. If the Prize cannot be awarded as described in these Contest Rules and Regulations, Contest Administrator and/ Vision Critical reserves the right to substitute a Prize or Prize component with another of comparable value, as determined in its sole discretion.

5.4. Refusal to accept the Prizes releases Contest Parties from any obligation toward the winner(s).

5.5. If a Contestant makes any false statement, (s)he will be automatically disqualified from the Contest.

5.6. Contest Parties assume no liability for any loss, damage or injury, including without limitation: (i) lost, stolen, delayed, damaged, misdirected, late, destroyed, illegible or incomplete entries; (ii) loss, theft or damage to software, computer or telephone data, including any breach of privacy; (iii) fraudulent calls; (iv) inability of any person to participate in the Contest for any reason including mistaken addresses on mail or e-mail; technical, computer or telephone malfunctions or other problems with computer on-line systems, servers, access providers, computer equipment, or software; congestion on the Internet or at any website, or any combination of the foregoing; (v) damage to any person's computer, including as a result of playing or downloading any material relating to the Contest; (vi) any delay or inability to act resulting from an event or situation beyond their control, including a strike, lockout or other labour dispute at their location or the locations of the organizations and businesses whose services are used to administer this Contest; or (vii) Prize that is lost, damaged or misdirected during shipping.

5.7. Contest Administrator reserves the right to cancel or suspend this Contest should a virus, bug or other cause beyond its reasonable control corrupt the security or proper administration of

the Contest. Any attempt to deliberately damage any website or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws. Should such an attempt be made, Contest Administrator reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.

All personal information, such as name and contact information, is collected by Contest Administrator and/or Vision Critical solely for the purposes of administering this Contest and shall not be used for any other purpose without Contestant's express consent. 5.9. If the identity of a Contestant is disputed, the authorized account holder of the e-mail address submitted at the time of entry will be deemed to be the Contestant. The individual assigned to the e-mail address for the domain associated with the submitted e-mail address is considered the authorized account holder. A selected Contestant may be required to provide proof that (s)he is the authorized account holder of the e-mail address associated with the selected entry. All entries must be submitted from a valid e-mail account that may be identified by reverse domain name search. The sole determinant of time for the purposes of receipt of a valid entry in this Contest will be the Contest server.

5.10. Odds of winning depend on the number of eligible entries. All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, using any robotic, automatic programmed method that artificially increases the odds of winning or do not conform to or satisfy any condition of the rules may be disqualified by the Contest Administrator.
